Location

The units are situated on a small industrial/warehouse development in the commercial and business area of Pin Green, close to the north-eastern outskirts of the town. Access to both Junctions 7 & 8 of the A1(M) are within approximately 2.5 miles by mainly dual carriageway. This is turn, provides access to the M25 in the south and the A14, M1, M6 and east coast ports in the north. Stevenage Railway Station provides regular services to London Kings Cross, approximately 23 minutes journey time.

Description

The properties are constructed from brick externally with internal block walls. The units have their own enclosed yards areas with double palisade gates and forecourt parking and are located at the mid-end of a terrace. They are available individually or combined. They benefit from new roofs.
