## Location

Stevenage is the major industrial and commercial centre for North Hertfordshire, situated adjacent the A1(M) between Junctions 7 & 8 and approximately 16 miles north of the M25. To the north, the A14 Huntingdon provides direct access to the M1, M6, north west and east coast ports. The town centre, with mainline railway station, is approximately 0.5 mile and provides fast and frequent railway services to London Kings Cross, approximately 22 minutes.

The property is located on an established industrial park and has a diverse commercial base with major employers including Glaxo Smith Kline, MBDA and Airbus.

## Description

The subject property is located in the middle of a terrace and offers mainly open plan warehouse space with ground floor office/showroom/mess room and offices to the first floor. There is a covered loading area with forecourt loading and parking and open plan warehouse.
